Duration: The duration of the Committee is three years. However, the Committee will continue till the formation of a new Committee.

Quorum: A quorum of three members is required to be present for the proceedings to take place. The quorum shall include the Presiding Officer (Chairperson) of the ICC, one member of the ICC and the third party representative / NGO Member.

Lodging of Complaint: (i) The aggrieved person has to make a formal complaint to the Chairperson of the ICC which may be a written complaint or through mail (Mobile No.-9438907220 email-id — complaint_posh@optcl.co.in with a copy marked to hr.amahapatra@optcl.co.in) and has to disclose her name, designation, phone number, department and place of posting in order to enable the Chairperson to contact her and take the matter forward.

(ii) In case the complaint is addressed / sent to MD / Director / Unit Head (in case of field units) or any other Committee Member, the same may be forwarded to the Convenor of the Committee.

Confidentiality: The Corporation and the Committee shall ensure confidentiality of the victim. In order to safeguard the interest / dignity of the victim, who may

report incidents of sexual harassment, complete confidentiality will be maintained throughout the investigation process to the extent practicable and appropriate under the circumstances.
