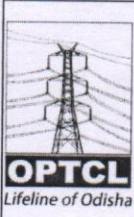

If any of the above date happens to be a holiday, the next working day will be the corresponding effective date. One Tender paper shall be issued to one Bidder. E.M.D Rs.4307.00 (Four thousand three hundred seven) only should be deposited in shape of Demand Draft only in favour of DGM, E.H.T. (O&M) Division, Kesinga & payable at Kesinga drawn on any Nationalized bank along with Self Attested Copy of Valid Civil Contract License, PAN and GST Registration Certificate failing which the tender will be liable for rejection.
